**Q1: (Rule 4 – Sections 2 and 3)**

Prior to either team gaining control on a jump ball to start the extra period, A-2 fouls B-2. Team B is in the bonus. The official awards B-2 a 'one and one' and has the scorer set the possession arrow when he/she places the ball at the disposal of B-2 for the first free throw. Is the official correct?

**Q2: (Rule 4 – Section 3)**

During an alternating possession throw in by Team A, B-1 fouls A-2. Team A is not in the bonus. The official awards the ball back to Team A then instructs the table to turn the possession arrow towards Team B's basket when the ball is touched in bounds or out of bounds. Is the official correct?

**Q3: (Rule 4 – Section 4)**

A-2, while standing in the back-court, bats A-1's throw in into the front-court where it hits A-3 and rebounds into the back-court. A-2 is the first to touch the ball. The official rules it a back-court violation. Is the official correct?

A-1 who is airborne and going to attempt a try has the ball batted from his/her hand from behind by B-1. A-1 prior to returning to the floor charges B-2. The official rules a player control foul, stating A-1 was an airborne shooter. Is the official correct?

**Q5: (Rule 4 – Section 4)**

A-1, in the front-court is dribbling near the division line. As A-1 pushes the dribble to the floor the ball touches the division line. As the ball bounces up and touches A-1, the official rules a back-court violation. Is the official correct?

A-1, while attempting to rebound, loses his/her balance and grasps the ring, pulling it down. After releasing his/her hand from the ring and before the ring returns to its original position, the ring contacts the ball. The official rules this basket interference. Is the official correct?

A – 1 is charged with a player control foul or a team control foul. Does the foul count towards A -1's disqualification should A-1 reach five personal fouls.
